NOTICE IS HEREBY GIVEN that the Santa Barbara Local Agency Formation Commission (Santa Barbara LAFCO) will conduct a public hearing at Saint Marks-in-the-Valley Church, 2901 Nojoqui Ave., Los Olivos, CA 93441 to receive written protests against the following:

Formation of the Los Olivos Community Services District (LAFCO File 17-01)

The proposed Los Olivos Community Services District (LOCSD) Formation was initiated by petition of the registered voters to form a district to address the collection, treatment, and disposal of wastewater. Formation of the LOCSD will allow this local agency to propose a Local Agency Management Program (LAMP) and comply with State Water Board's Water Quality Control Policy for Siting, Design, Operation, and Maintenance of Onsite Wastewater Treatment Systems.

The protest hearing will be conducted on **Wednesday, June 21, 2017 at 4:00 P.M.** by the Commission's Executive Officer. The protest hearing will adjourn at 4:45 P.M. To be valid, a protest must be:

- (1) Signed and dated
- (2) Received by the LAFCO office not later than June 21, 2017 at 4:45 P.M.
- (3) Not be faxed or emailed

Mail protests to Santa Barbara LAFCO, 105 East Anapamu Street, Room 407, Santa Barbara, CA 93101.

You must be a registered voter within the proposed LOCSD boundaries to file a protest. The protest form must be signed and dated by the addressee (registered voter) and must include your residential address. **A Post Office Box is not acceptable.**

There are 490 registered voters within the proposed LOCSD's boundaries. Fifty percent or more protests will terminate proceedings.

It is not necessary to attend the hearing. Protests submitted by mail are valid protests. All protests, mailed or in person, must be received no later than June 21, 2017 at 4:45 P.M.

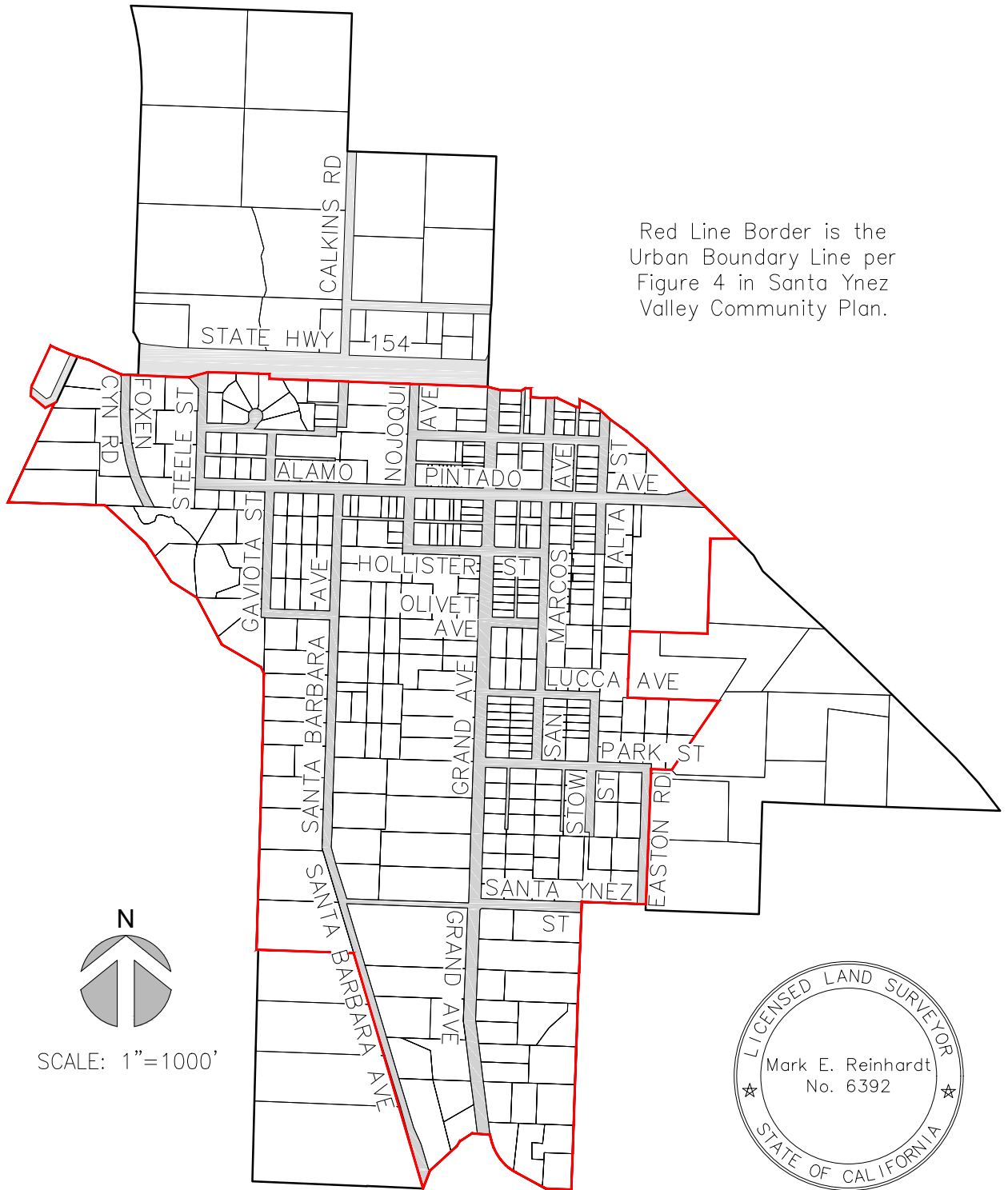

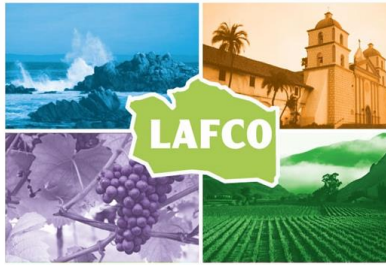
