The Special Mailed Ballot Election to form the Los Olivos Community Services District/Approve a Special Tax and Elect a Board of Directors, was held on January 30, 2018. The Certificate of the County Clerk-Recorder-Assessor of the results of the Canvass of All Votes Cast at the Election, was canvassed and signed on February 8, 2018 (Exhibit A).

The County Board of Supervisors will certify the Election results at the February 27, 2018 meeting. This will be followed by your Commission approving a Certificate of Completion at the April 5, 2018 meeting. The effective date of the formation will be the date that the Certificate of Completion is filed with the County Recorder's Office.

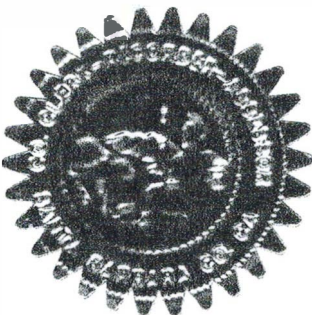
